Attachment to Articles of Amendment

Jaclyn Elisse Cares For Youth Foundation, Inc.

ARTICLE III

This corporation was created in memory of Jaclyn Elisse Torrealba. The corporation is organized exclusively for charitable and educational purposes within the mean of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code. The purposes of the corporation shall include, more specifically, bringing awareness to youth ranging from 13-19 years of age of teen domestic violence; assisting in educating and developing positive choices to minimize the epidemic of teen domestic violence, and doing reasonably related to the foregoing.

<u>ARTICLE IX</u>

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the appropriate court of the county in which the principal office of the corporation is then located, exclusively, for such purposes or to such organization or organizations, as the said court shall determine, which are organized and operated exclusively for such purposes.
