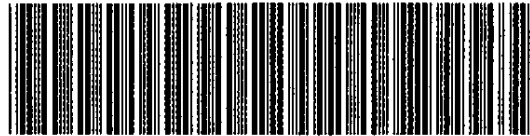



ARTICLES OF INCORPORATION OF A NOT-FOR-PROFIT CORPORATION

Under section 617.0202, F.S., of the Not-For-Profit Law.

The undersigned, for the purpose of forming a corporation pursuant to Chapter 617.0202, F.S., of the Not-For-Profit Law Corporation Law State of Florida, does hereby certify and set forth:

ARTICLE I NAME

The name of the corporation is: **Educating Children and Families, Inc.**

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE III PURPOSE

The purposes for which the corporation is formed are as follows:

Empowering women and teens who are victims of domestic violence by counseling them in the need for personal growth and development; these counseling sessions will be aimed at giving these women the tools necessary for promoting greater self esteem by encouraging them in the pursuit of higher education and stressing the need to take responsibility for their actions. One of our focal points will be geared toward improving the parenting skills of these women and offering practical and realistic opportunities for them to become engaged in a variety of effective support services that will enhance their lives and expand their worldviews; we will also be focusing on deterring teen dating violence for those with significant level of environmental risk. In addition, we will be teaching these women how to become active learners by helping them to overcome life obstacles as a reliable way to develop their inner strengths as well as a means for increasing areas of self-knowledge. We will guide them along the paths that lead to personal and familial stability while gaining skills that will allow them to advocate for themselves; they will also attain higher academic and cultural achievements in their lives and they will be experiencing the rewards of a nurturing domestic life as a member of a truly giving, family. In conjunction with these steps an effective after-school program will offer mentoring for youth who are from at-risk backgrounds, incorporating structured activities; actively engaging young learners through transformative performing arts experiences; assisting them at critical junctures in their educational and professional development; making imagination a part of the everyday learning experience by nurturing their creativity abilities; promoting and stimulating their imaginations to expand their inner and outer living situations: building support systems, increasing meaningful family engagement, encouraging social development and intellectual growth that will encourage them to become responsible, caring, and academically successful adults.

ARTICLE VIII DISSOLUTION
