This corporation is formed exclusively for religious and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Service. NO part of the earnings of the corporation shall inure to the benefit of or be distributed to the directors, officers, members, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments or distributions in furtherance of its religious or charitable purposes. Upon dissolution of the corporation, the assets shall be distributed to the existing denomination providing care and ecclesial authority over the corporation if that organization is then a tax-exempt organization within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code. No substantial part of the activities of the corporation shall carry on any propaganda, or otherwise attempting to influence legislation; and the corporation shall not participate in, or intervene in any political campaign on behalf of or in against any candidate.
