**Articles of Incorporation of  
SARASOTA COLLABORATIVE, INC.,  
a Florida Not For Profit Corporation**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE 1  
NAME**

The name of the corporation shall be: **Sarasota Collaborative, Inc.**, a Florida Not for Profit Corporation.

**ARTICLE 2  
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE 3  
PURPOSES**

The specific purpose(s) for which the corporation is organized is to:

Provide a team of skilled legal, financial and mental health professionals who are trained in the "Collaborative Practice" of divorce and other family law disputes which method encourages and fosters an alternative, more civil approach to resolving all types of family law disputes.
