**ARTICLES OF INCORPORATION
OF
OLYMPIA TITANS ATHLETIC ASSOCIATION, INC.**

The undersigned for the purpose of forming a corporation pursuant to Chapter 617 Florida Statutes (the "Act"), certifies as follows:

ARTICLE I

Name and Principal Place of Business

The name of this corporation (this "Corporation") shall be Olympia Titans Athletic Association, Inc., and its principal place of business and mailing address shall be 9367 Gotha Road, Windermere, Florida 34786.

ARTICLE II

Term

This Corporation, shall have perpetual existence from the date of filing of these Articles of Incorporation unless dissolved according to law.

ARTICLE III

General Purpose; General Powers

The purpose for which this Corporation is organized is the promotion of the common interest of its members in the operation of a youth football and cheerleading association as an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, not for pecuniary profit, having powers to perform the following activities for that purpose:

A. To operate a youth football and cheerleading association and all matters incidental thereto, including, but not limited to, the instruction in the fundamentals of football and cheerleading, the participation in football and cheerleading events and competitions, the collection of registration/participation fees, the raising of funds, the operation of game and practice field facilities and the expenditure of funds in connection with the foregoing; and

B. To carry on any and all lawful activities permitted to a corporation not for profit under the laws of the State of Florida. This Corporation shall have all of the powers conferred on a corporation organized under the Act as currently in effect and as it may be amended, and all such other powers as are permitted by applicable law, including without limitation all powers necessary or convenient to effect the purpose for which the Corporation is organized.

ARTICLE IV

Members

The qualifications for members and the manner of their admission and expulsion shall be as set forth in the Bylaws.

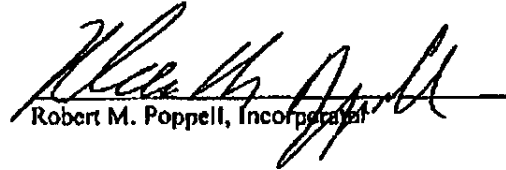
