Pursuant to the provisions of Section 617.1006, Florida Statutes, and Article XIII of the Articles of Incorporation for Canopy Creek Homeowners' Association, Inc., a Florida corporation not-for-profit (the "Corporation"), which filed Articles of Incorporation with the Florida Department of State Division of Corporations on June 18, 2013, the Corporation hereby desires to amend the Articles of Incorporation and adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Articles of Incorporation are amended to delete Article I in its entirety and replace it with the following:

"ARTICLE I. - NAME

The name of the corporation shall be THE CREEKS AT CITRUS PARK HOMBOWNERS' ASSOCIATION, INC., a Florida corporation not-for-profit (the "Association")."

2. This Amendment to the Articles of Incorporation was approved by D.R. Horton, Inc., a Delaware corporation, as the Developer and the sole Member of the Association, pursuant to Article XIII of the Articles of Incorporation.
