Compass Exploration, Inc., (Educational Multimedia), will not engage in prohibited political and legislative activity under 501 (c) (3):

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
