**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF  
THE SEASIDE PLAYGARDEN PRESCHOOL, INC.  
(A Florida not-for-profit corporation)**

Pursuant to Section 617.1006, Florida Statutes, THE SEASIDE PLAYGARDEN PRESCHOOL, INC., a Florida Not For Profit Corporation (the "Corporation"), does hereby amend its Articles of Incorporation as follows:

1. Article II of the Articles of Incorporation is hereby amended in its entirety to read as follows:

**ARTICLE II**

**PURPOSE**

**Section 1.** The Corporation is organized and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code"), including, but not limited to providing early childhood education to young people consistent with Waldorf principles, operating a family community center for parent education and resources as well as playgroups, conducting outreach to the community, providing young children and their families a healthy, creative environment in which to develop intellectually and socially, and encouraging a lifelong love of learning by giving young children the practical and academic skills necessary to meet life's tasks.

**Section 2.** All of the assets or earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. The property, assets, profits and net income of the Corporation are dedicated irrevocably to the purposes set forth herein. No part of the Corporation's profits or net earnings shall inure to the benefit of its directors, officers, members, or to the benefit of any individual.

**Section 3.** No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements in connection with) any political campaign on behalf of or in opposition to any candidate for public office.

2. Article IV of the Articles of Incorporation is hereby amended in its entirety to read as follows:

**ARTICLE IV**

**POWERS**

The Corporation shall have all powers of not-for-profit corporations now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to

carry out its purposes and objects.

3. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.

4. Pursuant to Section 617.1002, Florida Statutes, the amendment was adopted by the Board of Directors effective as of July 30, 2014. The Corporation does not have members.
