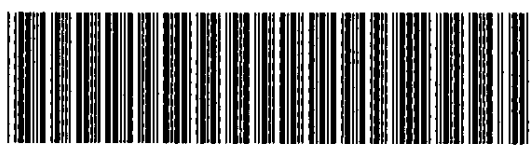

- ❖ **Fundraising Executive**: plans ways to raise money for various key programs
- ❖ **Volunteer Executive**: recruits volunteer from the community for specific projects.

Who can be a board member:

Executive officers are the only ones who are able become board members.

Term of office:

One term of a board member is three years. But, they have the choice to leave office one time at the end of every official business year.

Nomination process:

The nomination executive brings a list of names of people they have been working with who they feel will best fit the company.

How vaccines will be filled:

The names given by the nomination executive is voted on by the board of directors.

Define a quorum:

A quorum is a meeting consisting of 50% the board members.

Rules of Compensation:

- ❖ **If there is a convention of business trip out of town. The company will front the bill.**
- ❖ **Getting hurt on the job will be handled by the insurant company.**
- ❖ **Using your own car (if official business in public)gas will be paid for by the company. Food also will be paid in full by the company.**

Conflict of interest:

- ❖ **If there is a problem with two or more people working together. A meeting will be called, and a mediator will be called in try solve the issue.**
- ❖ **If someone has a problem with a job assignment. They will be pulled and a replacement will be picked.**

Powers of each officer on board of directors

- ❖ **Each officer may choose their own volunteers for the chosen assignment. Or ask the volunteer executive, and they will assign as many as you need.**
- ❖ **Has the power to choose how the job gets done. (If they know how, or have an idea.) They must first tell it to the board of director or the founder.**
- ❖ **Each officer has the right to remove someone (not fire) off a committee project if they feel like it will hinder or paint the company in a bad light.**

- ❖ **Each officer has the power to call and operate meetings with their own committee. As long as it's about a upcoming project or ongoing project.**

Vaccines of each officer of the board

- ❖ **If an officer of the board is going on vacation. Someone on the board will fill in for the time being.**
- ❖ **If an officer of the board besides to leave at the end of the term. The nomination process will be used. And the board of directors votes on it.**
- ❖ **If an officer gets sick, an officer of the directors votes on it.**
- ❖ **If an officer gets sick. An officer of the board will take over their duties until they get back.**

Responsibilities of each officer of the board

- ❖ **To complete every to the best of their ability.**
- ❖ **To stay within the budget of their committee.**
- ❖ **Not to put the company in a bad position with the community.**
- ❖ **To run their committee without conflict.**
