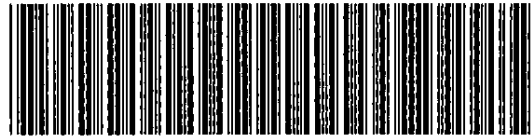

**ARTICLE I**

The name of the corporation (hereinafter referred to as the "Corporation") is YBY, INC.

**ARTICLE II**

The principal place of the business of the corporation is Unit 9, 12951 Metro Parkway, Ft. Myers, FL 33966.

**ARTICLE III**

- A. The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1954 (or the applicable provision of subsequent tax law). This includes but is not limited to the making of distributions to organizations that qualify as exempt organization=s under section 501(c) (3) of the Internal Revenue Code or corresponding section of any future code. More specifically, the following purposes are included:
1. To network youth and promote peer led activities for the purpose of mentoring and building up and encouraging through wholesome fellowship for the youth of Florida with faith based programming;
  2. To purchase property, real , personal or mixed or to receive the same by gift, bequest, devise or otherwise, and to own, use, operate, mortgage, lease or dispose of the same and to do all other necessary acts with respect to said property and in furtherance of the aforesaid purposes;
  3. To engage in any other activities deemed necessary for the accomplishment of the aforesaid purposes;
  4. To do any and all lawful acts and things which may be necessary, useful, suitable or proper for the furtherance or accomplishment of the purposes of the Corporation, provided however that the Corporation shall not carry on any activity not permitted to be carried on by (a) a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or provision of any subsequent tax law) and (b) a corporation contributions to which are deductible under section 170 of the Internal Revenue "Code of 1954 (or corresponding provision of any tax law including but not limited to the 1986 Revised Tax Code).
- B. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons or any individual. The Corporation shall, however, be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of its purposes in furtherance of Section 501(c) (3). No substantial part of the activities of

the Corporation shall be the carrying on of propaganda , or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue "Code of 1954 (or corresponding provision of any future Federal tax code).

The foregoing clauses shall be construed as general projects, purposes and powers, and shall not be held to limit or restrict in any manner the powers of the Corporation permitted by law.

**ARTICLE IV**

The manner in which Directors are elected and appointed is by majority ballot at annual meetings.

**ARTICLE V**
