ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CRETARY OF STATE! DONALD W. WALLACE AND ERIKA R. WALLACE FAMILY EQUINDATION, FINERIDAL.

Pursuant to Section 617.1006 of the Florida Statutes, Article 4 of the Articles of Incorporation of Donald W. Wallace and Erika R. Wallace Family Foundation, Inc., a Florida not-for-profit corporation, is hereby amended as follows:

ARTICLE 4 Board of Directors

The Corporation shall have three (3) directors. The number of directors may be either increased or decreased from time to time in the manner provided in the bylaws, but shall never be less than three (3). The method of appointment of directors shall be as stated in the bylaws of the Corporation, but such appointment power shall be vested in the members and such appointment shall occur no less frequently than every two (2) years.
