**ARTICLES OF INCORPORATION FOR

We, the undersigned persons of the state of Florida, all of whom are of legal age, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

**ARTICLE I – NAME**

The name of this corporation shall be TEMPLO CRISTIANO VIDA, INC., with its principal place of business located at 4600 NW 9<sup>TH</sup> COURT #1, City of plantation, state of Florida, zip code 33317. The name of this corporation registered agent is Osman Morales and his address is 11363 pickford street, springhill, FL 34609

**ARTICLE II – PURPOSE**

The general nature, object and purpose of this corporation is as follows:

- A. To establish and maintain a place for the worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith, were the Holy Spirit may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.

**ARTICLE III- ORDINANCES**

**1. WATER BAPTISM:**

The ordinance water baptism (Matthew 18:19) should be administered to all believers in the having obtained salvation. (Romans 6:3-5, Colossians 2:19-20; 1 Corinthians 11:23-26) believers will be baptized by immersion in the name of The Father, The Son and the Holy Spirit.

**a. THE ORDINANCE OF THE LORD'S SUPPER:**

Will be done regularly, just as the Holy Scriptures say it should be done. (Luke 22:19-20, 1 Corinthians 11:23-26)

## ARTICLE IV-MEMBERS

### 1- REQUIREMENTS OF MEMEBERS:

The opportunity to be an active member of the church should be offered to all persons that meet the following requirements:

- A. A testimony of the new birth experience.
- B. Water baptism by immersion.
- C. Evidence of a consistent Christian life. (Romans 6:4, 8:1-4, 13:13-14, Ephesians 4:17-32; 5:2,2,15 ; 1 John 1:6,7)
- D. A sign that is willing to provide regularly with church finances.
- E. Acceptance of the fundamental truths set forth in this constitution.
- F. Must be at least 15 years of age, with parental consent.
- G. Must have attended and supported this church for a period of three consecutive months before the date of application to be accepted as a member.
- H. Will be subjected to the rules of the church, which can be amended.

### 2- DISCIPLINE

#### A. Background:

Discipline is an action exerted with authority of the scripture and the church is responsible. (Matthew 16:19, 18:15-20, Luke 17:3, John 20:23, Acts 16:4, Ephesians 5:11. 1 Timothy 5:20, 2 Timothy 4:2. Hebrews 13:17) the purpose of discipline is to promote repentance and restoration to bring to light the sinful behavior.

Should be redemptive and corrective in nature. Any church member will be subject to discipline or behavior because of the separation of the principles of faith of the church.

## PRIVILEGES

### 1- TO GOVERN:

This church has the right to govern themselves and conduct their own affairs in accordance to the standards of Scripture, under the system of the government of the New Testament.

### 2- TO ACQUIRE AND DISPOSE:

In connection with, or incidental to, this church shall be entitled to purchase, or purchase a gift of donation or otherwise, either directly or as a trustee to own, receive in trust, transfer, mortgage, rent, or otherwise selling or dispose real property or personal property as needed to promote their purposes and to

exercise powers conferred by law or by the non-profit corporation law of this state, all in accordance with the regulations as some may be amended.

3- TO RECOGNIZE:

This church has the authority and the right to approve biblical doctrine and behavior. May also disapprove false doctrine and misconduct if necessary, overrule member certificates.

#### ARTICLE V-RESPONSIBILITIES

1. The Pastor shall be responsible for the general management of the affairs of the church, and the authority to carry out the purpose of the church in accordance with its constitution and bylaws. Pastor coordinate and delegate work of the wider church group leaders according to their position.
2. Appoint a secretary and a treasurer, who will be part of the group of leaders. Pastor submit candidates for these positions and the rest of the group leaders will elect by majority vote. Shall be elected for one year and may be reappointed each year.

3. LEADERS:

The leaders will be full members of the church, with maturity and experience. Leaders should be at least 23 years of age and a member of the church for a minimum of one year. They should support the church with their tithes and offerings, must have a spirit of cooperation and attend meetings regularly. The leaders will be appointed for a term of one year and may be reappointed each year. Any position of leadership in the church (except the pastor) may be suspended, for moral faults tested by disrespect for authority, lack of restraint or any other matter requiring a penalty.

4. DUTIES OF SECRETARY AND TREASURER:

A. SECRETARY:

Shall keep a record of the minutes of official meetings. Maintain register of members of the church and perform any other necessary paperwork to fulfill its responsibility. Shall have custody of all legal documents of incorporation.

#### ARTICLE VI- PROPERTIES

TITLE:

1. All church property will be registered and filed in the name of the church "Templo Cristiano Vida".

DISSOLUTION:

In case of dissolution of the church, or any equity fund will be distributed to members or leaders, or any other individual. The church after paying or providing for the payment of liabilities of the same hand over all funds and capital of the

church to one of the smaller churches with fewer resources, members of the mission to which it belongs.

#### ARTICLE VII- FINANCES

1. OVERALL:

All funds for the maintenance of the church, will be provided through contributions voluntary tithes and offerings of church members. (Malachi 3:10, Luke 6:1-2. 2 Corinthians 9:6-8). These will be received by the treasurer of the church and will be under supervision of the pastor.

2. MANAGEMENT OFFERINGS:

All offerings received for services, will be counted by at least two authorized persons before the funds are remove from the church. Those in charge of counting the offerings must sign a receipt and give a copy to the pastor and one for the treasurer. It shall maintain a record of all receipts and disbursements of the church, and offerings received.

3. REMUNERATION OF THE PASTOR:

The pastor will be paid for their services with a fair wage, and according to the general church entrances.

4. REIMBURSEMENTS COST:

The treasurer will reimburse the pastor expenses incurred during church-related activities.

#### ARTICLE VIII-AMENDMENTS

The regulations of this church may be amended. All checks drawn on behalf of the church will be signed by the treasurer and the pastor and in case of the absence of one of the two, the secretary is authorized to sign. Keep a detailed record of the receipts and disbursements to be made by the church. Provide a report to each donor of all the offerings made during the year. Submit a financial report of the general movement, especially if any member was to request it. Shall always have custody of all financial records of the church.

#### ARTICLE IX-FIRST OFFICERS

The name of the officers who are to manage the affairs of this Corporation, and the office which they will respectively hold until their successors are selected and qualified, and are as follow:

President and Trustee: Osman Morales.

Secretary and Trustee: Juliana Tabares.

Treasurer and Trustee: Alfredo Romero.

Trustee: Manuel Palacios.

Trustee: Yadir Morales.

## ARTICLE XI - BYLAWS

The bylaws of this church are to be made, altered or rescinded by a majority of the qualified members present and voting at any properly called business meeting of the church, which shall be two weeks in advance of such business meeting, at which a quorum is present. The previous First Officers were elected by Majority of Votes.

## ARTICLE XII - REGISTERED AGENT CERTIFICATE

In pursuance of Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:


