for Celebrate Service Corp., a Florida non profit corporation

ARTICLE I NAME

The name of the corporation is Celebrate Service Corp.

ARTICLE II PRINCIPAL OFFICE AND STREET ADDRESS

The address of the initial principal office of the corporation is 18495 S. Dixie Highway, Suite 376, Cutler Bay Florida 33157-6817 and the mailing address of the corporation is the same.

ARTICLE III DURATION

The term of existence of the corporation is perpetual and the corporate existence will commence upon the filing of these Articles with the Department of State.

ARTICLE IV PURPOSE AND RESTRICTIONS

The purpose for which the corporation is organized, not for pecuniary profit, is to provide marketing, public relations and other services to organizations that actively support love and inclusivity, help to build community and fight public corruption. The corporation will provide educational and professional expertise in order to assist institutions to sustain better marketing, public relations and fund-raising activities. The corporation will operate, administer and supervise trusts and endowments established by donors.

The corporation's services shall be paid from the rentals derived from income producing real property donated to or owned by the corporation. The corporation shall use and apply the whole or any part of the income therefrom and the principal thereof exclusively for the charitable or educational purpose described herein.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director, Officer or Member of the corporation, or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation, and reasonable expenses may be paid thereto, affecting one or more of the corporation's purposes) and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

The corporation shall not engage in any act of self-dealing, but is authorized to buy, sell, manage and maintain all properties owned and/or entrusted to the corporation.

The corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and regulations issued pursuant thereof as they now exist or as hereinafter amended.

The corporation shall have all corporate powers as provided by Florida Statute 617.0302 and 617.0303.




