Article III is amended to read as follows:
This corporation is organized exclusively for charitable, religious, and educational purposes, including for such purposes,
the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal
Revenue Code, or the corresponding section of any future tax code.
Article IX is added to read as follows:
A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors
(also known trustees), officers, or other private persons, except that the corporation shall be authorized and empowered to
pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set
forth herein.
B. No substantial part of the activities of the corporation shall be carrying on of the propaganda, or otherwise attempting to
influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of
statements) any political campaign on behalf of or in opposition to any candidate for public office.
C. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted
to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code.

- D. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- E. Matters of governance, including without limitation rules pertaining to membership in the corporation, and election and removal of directors (also known as trustees), shall be as provided in the bylaws of the corporation.
- F. These articles of incorporation shall be amended by affirmative vote of a majority of the members of the Board of Directors (also referred to as the Board of Trustees) at a meeting duly called for such purpose.
