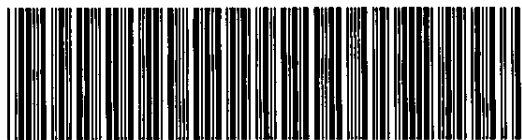

AMEND AND REPLACE ARTICLE III WITH THE FOLLOWING:

Incorporated for educational (or other exempt) purposes within the meaning of IRC § 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, the corporation's members (if any), directors, officers or other private persons. All assets of the corporation are dedicated to educational purposes and upon dissolution of the corporation shall only be distributed for one or more exempt purposes within the meaning of IRC § 501(c)(3), as amended or replaced from time to time, or shall be distributed to a federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the court of appropriate jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such IRC § 501(c)(3) exempt purposes or to such governments, as that court shall determine that are organized and operated exclusively for such IRC § 501(c)(3) exempt or public purposes.

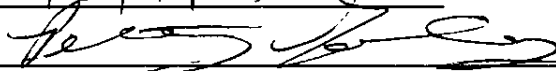
