A Non Profit Corporation with No Members

The undersigned incorporator does hereby make, file and acknowledge these Non Profit Articles of Incorporation for the purpose of forming a corporation under the Florida Not For Profit Corporate Act, and hereby adapt(s) the following Articles of Incorporation and state the following.

#### ARTICLE I

#### NAME OF THE CORPORATION -

The name of this corporation shall be Smallwood Family Literacy Acade

#### **ARTICLE II** PURPOSE(S) THE NATURE OF BUSINESS

The purpose(s) for which this corporation is formed and organized are: This is a non-stock, non-profit corporation. This corporation will engage in, but shall not be limited to the following activities: To decrease illiterate homelessness, crime, violence, substance abuse, sexual abuse and domestic violence by increasing Academic Liter, Weational Literacy and Employment Skills through the establishment of Home Based and Community Based Academic Literacy programs, Educational Support Services, Vocational Rehabilitation Trainings, Residential Housing, Personal Care Assistance and Healthy Nutritional provided to Low to Moderate Income Individuals, At-Risk Youth & Adults, People with Disabilities, Limited Mental Health Issues. Smallwood Family Literacy Academy, Inc., may also purchase, sell, lease, invest in and /or transferring real estate property(ies) to and from charitable, philanthropic public and private organizations. The four ways this purpose will be accomplished are:

- To Provide Academic Literacy, Supplemental Educational Support Services, Vocational Rehabilitation Training, Employment Skills, Residential Housing Support, Personal Care Assistance and Healthy Nutrition to low to Moderate Income Individuals who are At-Risk Youth & Adults, People with Disabilities, and Limited Mental Health Issues to promote self-esteem, dignity, independence and self-sufficiency.
- The presentation of Academic and Vocational Literacy, educational support services both In-Home, and 2. Community Based Supports that link At-Risk Youth, Adults, People with Disabilities, and Limited Mental Health Issues, to Literacy Training, Smallwood's, staff will provide Literacy Training, watchful oversight, and support services to assist in increasing, literacy, self-esteem, dignity, independence and self-sufficiency. 3.
- The publication and distribution of Literature concerning Academic Literacy and Vocational Rehabilitation For At-Risk Youth & Adults, People with Disabilities, and Limited Mental Health Issue's needs, services and resources. Smallwood Family Literacy Academy, Inc. will Expose, Educate and bring Experience via creative Activities that will contribute to the edification of these individuals self-esteem, dignity and character in an abuse, neglect and exploitation free environment that fosters learning, healthy nutrition, honoring their civil rights, health, safety and be therapeutic in nature while diversity in culture will be celebrated. Information on reducing illiteracy, homelessness, crime; violence, substance abuse, sexual abuse will be provided to assist in increasing self-sufficiency and employability skills.
