ARTICLE I - NAME OF CORPORATION

The name of this Corporation is **BISCAYNE NEIGHBORHOODS ASSOCIATION**, **INC**.

ARTICLE II - DURATION

This Corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.
