ARTICLE I Name

The name of this Corporation shall be The Fairholme Unlimited Foundation. Inc. (hereinafter called the "Corporation").

ARTICLE II Principal Office

The address of the principal office and the mailing address of the Corporation shall be 4400 Biscayne Blvd. 9th Floor Miami, FL 33137.

ARTICLE III Purpose

Upon the dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

- C. The Corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Code, or corresponding provisions of subsequent federal tax laws.
- D. The Corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Code, or corresponding provisions of any subsequent federal tax laws.
