ARTICLES OF INCORPORATION OF ANDREW SAVYSKY AND TANYA SAVYSKY CHARITABLE FOUNDATION, INC. a Florida Not-For-Profit Corporation

The following constitutes the Articles of Incorporation of Andrew Savysky and Tany Savysky Charitable Foundation, Inc.:

ARTICLE I - NAME

The name of the corporation is ANDREW SAVYSKY AND TANYA SAVYSKY CHARI FOUNDATION, INC. (the "Corporation")

ARTICLE II - ADDRESS

The address of the principal office and mailing address of the Corporation is:

ARTICLE III - PURPOSE

The Corporation is organized exclusively for, and limited to, <u>charitable</u>, <u>educational</u>, <u>religious and scientific purposes under Section 501(c)(3) of the Internal Revenue Code</u>, or <u>corresponding section of any future federal code</u>.

<u>ARTICLE IV – ELECTION OF DIRECTORS</u>

Directors of the Corporation are appointed as provided in the bylaws of the Corporation.
