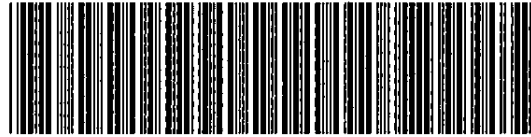

The undersigned incorporator for the purpose of forming a not for profit corporation pursuant to Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME.

The name of the corporation shall be HEARTLAND CHURCH OF CHRIST IN SEBRING, FLORIDA, INC.

**ARTICLE II: PRINCIPAL PLACE OF
BUSINESS AND MAILING ADDRESS**

The address of the principal office and mailing address of the corporation is 3810 Thunderbird Hill Circle, Sebring, FL 33872.

ARTICLE III. PURPOSE

The purpose of this corporation is religious, to bring persons into a saving and redemptive relationship with Jesus Christ. We are a spiritual body whose only foundation is the Word of God. ARTICLE IX. COMPLIANCE WITH REQUIREMENT OF INTERNAL REVENUE CODE SECTION 501(c)(3) AND SECTION 170(c)(2)


No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to

make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of this corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding sections of any future federal tax code.

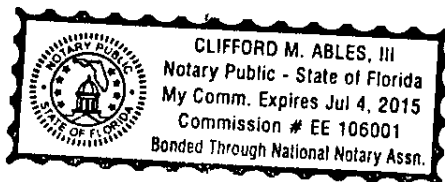


