ARTICLES OF INCORPORATION OF

**PROVIDENCE AND MERCY
IN ACTION MINISTRIES INC.**

The undersigned incorporators are individuals of full age of majority, and residents or citizens of the United States of America and adopt the following articles of incorporation to form a **non profit** Corporation pursuant to the Florida Non Profit Corporation Act, Chapter 617.

ARTICLE I — NAME

The name of this corporation is PROVIDENCE AND MERCY IN ACTION MINISTRIES INC.

ARTICLE II — DURATION

The Corporation shall be perpetual. The corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE III — PURPOSE

This corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501c (3) of the Internal Revenue Code (or the corresponding provision of any future United States internal revenue law) including the making of distributions to or for the use of organizations exempt at the time under Section 501c) (3) of the Internal Revenue Code (or the corresponding provision of any future United States internal revenue law).

This Corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.

Notwithstanding any other provision of the Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 c)(3) of the Internal Revenue Code (or corresponding section of any future Federal Tax code) or (b) by a corporation contributions to which are deductible under Section 170 c)2) of the Internal Revenue Code 9 or corresponding section of any future tax code).

Specifically, the purpose of the Corporation is to collect and share information to support minors that live in poverty within and out of the country, to support and educate the homeless in the City of Tampa, to spread the Gospel of Jesus Christ, and to educate individuals from any evangelical congregation willing to participate in the mission of this corporation. To achieve its purpose the corporation will seek grants from the federal, state and local governments and pursue contributions from the private sector.

The purpose of this corporation is to collect material resources that will also include grants from Federal, State, and local government Agencies and the Private sector:

- To support minors that live in poverty within and out of the country.
- To support and educate homeless in the city of Tampa Florida.
- To educate individuals from any evangelical congregation willing to participate in the mission and purpose of this corporation.
- To spread the Gospel of Jesus Christ.

ARTICLE IV — INITIAL BOARD OF DIRECTORS

ARTICLE VII – CONDUCT OF CORPORATE AFFAIRS

The conduct of the affairs of the Corporation will be limited as outlined in the By-laws of the Corporation. The powers of the Corporation are to be regulated as outlined in the By-laws of the Corporation. The manner in which directors are elected or appointed will be as provided in the By-laws of the Corporation.

ARTICLE VIII – DISSOLUTION OF CORPORATE AFFAIRS

Upon dissolution of the Corporation, the Board of Directors, shall, after paying or making provisions for the payment of all liabilities of the Corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes, and shall at that time qualify as an exempt organization or organizations under section 501(c)3 of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

The Board of Directors shall determine that assets not disposed of shall be disposed of by the circuit court of the county in which the principal office of the corporation is then located, exclusively for such purpose or purposes or to such organization or organizations, as said court shall determine are organized and operated exclusively for the purposes aforementioned.

ARTICLE IX — QUALIFICATIONS FOR MEMBERSHIP

The Corporation reserves the right to determine who may be part of this ministry and will be regulated under the By-Laws.
