ARTICLES OF INCORPORATION OF 13 JUL 23 AM 11:09 ANOTHER STEP ANOTHER JOURNEY MINISTRY, INC. A FLORIDA NONPROFIT CORPORATION DECRETARY OF STATE TALLAHASSEE FLORIDA

The undersigned for the purpose of forming a nonprofit corporation under the Florida Not For Profit Corporation Act, Florida Statutes Chapter 617, do hereby make and adopt the Following Articles of Incorporation:

Article 1 Name. The name of the Corporation is: Another Step Another Journey Ministry, Inc. with its principal address at. 3410 Handy Rd, Tampa, FL 33618

Article 2. Not for Profit. The Corporation is a corporation not for profit as defined in the Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members Directors or Officers, except to the extent permissible under law.

Article 3. Duration. The duration (term) of the Corporation is perpetual.

<u>Article 4. Purposes.</u> The Corporation is organized, and shall be operated exclusively for, the following purposes

A. The corporation is organized and shall be operated exclusively for charitable purposes for the care, career and education opportunities of adults, youth and children in need during and after a crisis (divorce, abuse, orphan, unemployment, disaster relief and loss of a loved one) and it is authorized to engage in any and all lawful activities incidental to the foregoing purposes, except as restricted herein. The Corporation shall neither have nor exercise any power, nor shall it engage directly or indirectly in any activity, that would invalidate its status: (1) as a corporation which is exempt from federal income taxation as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986; or (2) as a corporation contributions to which are deductible under Section 170 of the Internal Revenue Code of 1986.

All of the assets and earnings of the corporation shall be used exclusively for the purposes hereinafter set out, including the payment of expense incidental thereto; and no part of the net earnings of the corporation shall inure to the benefit of any private shareholder or individual. No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation; nor shall the corporation participate in or intervene in (by the publishing or distributing of statements or otherwise) any political campaign on behalf of any candidate for public office.

In the event of dissolution of the corporation, all of the remaining assets of the corporation after payment of its liabilities shall be distributed only for scientific, educational and charitable purposes to one or more organizations which meet the requirements of 501(c)(3) and to which contributions are deductible under Section 170 of the Internal Revenue Code of 1986, as the Board of Directors shall determine.

- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort to nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.
- C. To do such other things as are included to the purposes of the Corporation or necessary or desirable in order to accomplish them.
 - D. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- E. Upon the dissolution of the corporation, assets shall be distributed for one or More exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the corporation is then located, exclusively for such purposes.
- Article 5. Limitation. No part of the net earnings of the Corporation shall insure to the benefit or be distributed to its Members, Directors or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in Article 4 (Purposes) hereof.

Article 6. Members. The Corporation shall have Voting Members who shall be elected (and may be removed) by the Voting Members and shall have all the rights and privileges of members of the Corporation. The name and addressed of each initial Voting Member is as follows:

Article 7. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 3410 Handy Rd, Tampa, FL 33618 And the name of its initial Registered Agent at the address is Eleanith Ramos-Carde

Article 8. Initial Board of Directors. The management of the Corporation shall be vested in a Board of Directors. The number of Directors constituting the initial Board of Directors is three (3). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three (3). The Voting Members shall never be less than two (2). The Voting Members shall elect the Directors at an annual meeting of Voting Members. The Bylaws may provide for ex officio and honorary Directors, and their rights and privileges. The Corporation is organized and shall be operated on a nonstick basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock or other certificates or writings evidencing an ownership of proprietary interest in the Corporation.
