ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

MINISTERIO EL RENUEVO, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

1. The purpose for which the corporation is organized are to receive and maintain real or personal property, both, and, subject to the restrictions and limitations here in after set forth, to use and apply the whole or any part of the income there from and the principal thereof exclusively for charitable, religious, scientific, literary or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

2. The specific purpose for the corporation is organized shall be: RELIGIOUS SERVICES

To erect and maintain a building or buildings for the above purpose and to engage in any operation incidental to an essential to carry out the purpose above mentioned.

To solicit funds and donations in kind and from time to time to further purposes of this corporation.

- To acquire and receive by purchase, donations or otherwise, any property, real personal or mixed, and hold, use and dispose of the same.
- 6. To borrow money and to issue evidences of indebtedness in furtherance of any or all of the objects of its business; and to secure loans by mortgage, pledge, deed of trust, or other lien.
- 7. To apply for, obtain and contract with any federal, state or local government or agency for a direct loan or loans or other financial aid in the form of grants or otherwise relating to the purpose of this corporation.
- 8. To engage in any kind of activity, and to enter into, perform and carry out contracts of any kind, necessary or in connection with, or incidental to the accomplishment of any one or more of the non-profit purpose of the corporations.
- 9. No part of the earnings of the corporation shall inure to the benefit of, or be distributable to any Director or Officer of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distributions of any of the corporate assets on dissolution of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publications or distributions of statements) any political campaign on behalf of any candidate for public office.
- 10. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be conducted or carried on by any organizations exempt from taxation under Section 501(c) (3) of the Internal Revenue Code and Regulations issued pursuant here to as they now exist or as they may hereafter be amended or by organization, contributions to which are deductible under Sections 170(c) (2) of the Internal Revenue Code and said Regulations as they now exist or as they may hereafter be amended.
- 11. Upon the dissolutions of the corporation, the Board of Directors shall, after paying or making provisions for the paying of all of the liabilities of the corporation, disposes of all of the assets or the organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Circuit Court of Miami-Dade County, Florida in which the principal office of the corporations is then located, exclusively for such purposes or to such organization or organizations, as said script shall determine, which are organized and operated exclusively for such purposes.

SECRETARY OF STATE

The corporation shall have such powers as are conferred upon it by Chapter 617 of the Laws of the State of Florida, and to exercise those powers in the accomplishment of its object and purposes.
