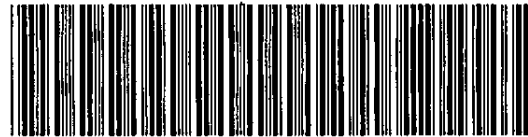

Article III:

Our purpose is to not only assist in meeting the unmet needs of underprivileged at risk youth, i.e. basic essentials clothing, school supplies, etc. but, we also will provide opportunities of collaboration with their peer equals, namely those who exhibit leadership potential through community involvement and volunteer services.

Said organization is organized exclusively for charitable, religious, education and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon dissolution of the corporation, asset shall be distributed for one of more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such an organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
