The undersigned, acting as incorporations of corporations pursuant to Chapter 617, Florida statutes, adopts the following Articles of incorporations.

I

The name of the corporations shall be:

II

The principle office of the corporation shall be located at 10237 Normandy Cove Street Jacksonville, Florida 32221

III

The specific purposes for which the corporation is organized are (1) Specific of the living facilities with intent to positively change and enhance the quality of life of the physical and mentally disable. (2) The provision of permanent and temporary transitory housing of the physical and mentally disables. (3) To serve as a referral service catering to the psychological and physical needs of the physical and mentally disable. The board of directors shall be appointed and governed according to the BY-laws set by the corporations.

V

No part of the net earnings of the corporations shall insure to benefit of, or be distributable to its members, trustees, office, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of the purpose set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not with standing any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future of any future federal tax code.

“Notwithstanding any other provisions of these articles this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are in furtherance of the purpose if this corporation”

VI

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 © (3) corporation. “However” if the named recipient is not in existence or no longer qualified as distributed to a fund, foundation,
