**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
SUNTREE VIERA PROFESSIONAL PARK OWNERS ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1002, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I is hereby restated as follows:

**ARTICLE I
NAME**

The name of this corporation shall be **BREVARD MEDICAL CITY OWNERS ASSOCIATION, INC.** ("Association"). The terms contained in these Articles of Incorporation ("Articles") shall have the same meaning as set forth in the Declaration of Condominium of Brevard Medical City, formerly known as Suntree Viera Professional Park unless otherwise defined herein.
