Pursuant to section 617.1403, Florida Statutes, this Florida not-for-profit corporation submits the following Articles of Dissolution:

FIRST: The name of the corporation as currently filed with the Florida Department of State is Southwest Florida Economic Development Alliance, Inc.

SECOND: The document number of the corporation is N13000006943.

THIRD: On April 30, 2020 the Board of Directors approved a plan to liquidate and dissolve the Corporation. The meeting was duly called and noticed and 7 of the 8 members of the Board of Directors attended, comprised a quorum, and voted in favor of the dissolution. On May 20, 2020, in accord with Fla. Stat. §617.0821, the entire Board of Directors unanimously approved in writing the filing of these Articles of Dissolution and a Plan of Liquidation and Dissolution.

FOURTH: The effective date of dissolution is May 31, 2020.


