In compliance with Chapter 617, F.S., Florida Not For Profit Corporation Act.

ARTICLE I NAME

The name of the corporation shall be: The Community for Personal Development, Inc.

ARTICLE III PURPOSE

The corporation is organized to provide educational activities and programs. Educational programs with focus on personal and emotional development. Students will heal from past mental and/or emotional traumas, learn new communication and interpersonal skills, and face fears and obstacles that have previously hindered prosperous and productive lives.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
