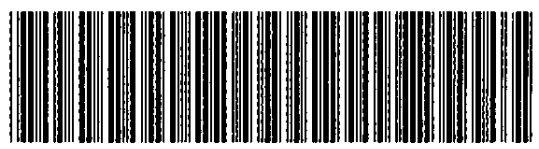

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., Florida Not For Profit Corporation Act.

ARTICLE I NAME

The name of the corporation shall be: The Community for Personal Development, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The corporation is organized to provide educational activities and programs. Educational programs will focus on personal and emotional development. Students will heal from past mental and/or emotional traumas, learn new communication and interpersonal skills, and face fears and obstacles that have previously hindered prosperous and productive lives.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The Corporation may engage in any and all other lawful activities incidental to and in pursuit of the foregoing purposes.

The Corporation shall not be conducted or operated for profit, and no part of the net earnings of the Corporation shall inure to the benefit of any director, officer, employee, or person connected with the Corporation; provided, however, that this shall not prevent the payment to any such person of reasonable compensation for services rendered to or for the Corporation in effecting any of its purposes.

ARTICLE IV MANNER OF ELECTION

The Corporation shall adopt Bylaws, which shall set forth the procedures for the election of directors of the Corporation, and may contain such other provisions for the regulation of the affairs of the Corporation as from time to time shall be deemed advisable. Such Bylaws are to be adopted and amended by the Board of Directors.

ARTICLE VI DISSOLUTION CLAUSE

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose.
