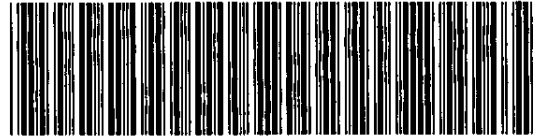

AMEND Article III: The purpose of Adopt Your Strings Corp is to collect orchestral string instruments and instrument accessories through fundraising and donations so the instruments and accessories may be given to orchestral students who have difficulty affording their own instruments. This corporation is organized exclusively for charitable purposes as defined by section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that this corporation shall be authorized and empowered to make payments and distributions in furtherance of the charitable purposes set forth above. No substantial part of the activities of this corporation shall be to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. This corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ADD Article of Dissolution: Upon the dissolution of Adopt Your Strings Corp, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


