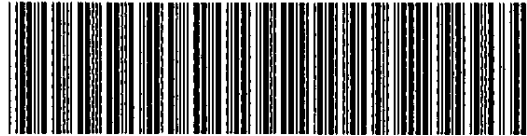

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 689, Florida Statutes, adopt s) the following Articles of Incorporation of such corporation:

**ARTICLE I**

**ARTICLE II**

The period of duration of this corporation is perpetual unless dissolved according to law.

**ARTICLE III**

The purposes for which the corporation is organized are:

1. To encourage and promote the evangelization of the world.
2. To encourage and promote the worship of God.
3. To encourage and promote the edification of believers.
4. To establish and maintain such departments as may be necessary for the spreading of the gospel.
5. To have the right to own, hold in trust, use, sell, convey, lease, mortgage, or otherwise dispose of property, real or chattel, as may be needed to carry forth its work.
6. To have the right to establish and maintain churches and train and ordain ministers as may be needed to carry forth its work.
7. The purpose for which the Ministerio de Reconciliacion Nueva Vida, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.




