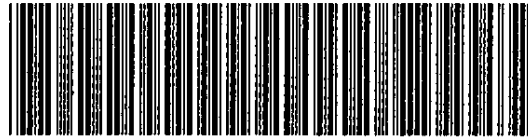

I

The name of this corporation is BoldTunes Inc.

II

The principal office of the corporation is located at 350 NW California Blvd, Port St Lucie FL, 34986.

III

- A. This organization is a not for profit corporation and is not organized for the private gain of any person. It is organized under the Florida Not for Profit Corporations Act to provide cultural enrichment to individuals and communities.
- B. This corporation is specifically organized exclusively for the presentation of cultural events, including musical concerts, for educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

IV

- A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article III hereof.
- B. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of said Code, or the corresponding provisions of any future statute of the United States.
- C. No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation; nor shall the corporation participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.

V

In addition to the Chief Executive Officer and the Secretary/Treasurer, who shall both serve as voting members of the Board of Directors, three additional Directors shall be appointed by the Chief Executive Officer, each to serve a one-year term.

Upon the dissolution of the corporation, any assets remaining after payment of, or provision for payment of, all debts and liabilities shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Codes, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.
- C. Any such assets not so disposed of shall be disposed of by a Court of Competent jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
