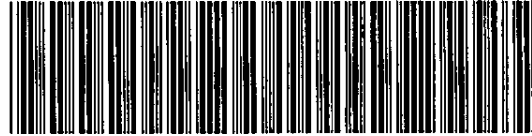

ADD ARTICLE III - THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED ARE EXCLUSIVELY  
RELIGIOUS, CHARITABLE & EDUCATIONAL WITHIN THE MEANING OF SECTION 501(C)(3) OF  
THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE
