

Each individual shall disclose to the organization any personal interest which he may have in any matter pending before the organization and shall refrain from participating in any decision on such matter.

Any member of the Board of Directors, or any of the afore mentioned individuals of a client organization or vendor of Hope Church of Christ Inc. Nonprofit shall identify his affiliation with such agency or agencies; further, in connection with any committee or Board action specifically directed to that agency, he shall not participate in the decision affecting that agency and the decision must be made and/or ratified by the full Board. Any member of the Board, any Committee, Staff, Trustee, and Certain Consultants shall refrain from obtaining any list of clients for personal or private solicitation purposes at any time during the term of their affiliation.
