

Help-Save-A-Limb Inc

Action #1: Add Article IX

The specific purpose for which this corporation is organized is to increase awareness of the preservation of limbs and joints as a positive alternative to amputation through informative community outreach, fundraising activities, and discussion forums catering to the spiritual, logistical, and financial support of families undergoing or facing treatment.

Through grass roots and corporate fundraising efforts, all monetary contributions collected are expressly donated for the direct benefit of the Save-A-Limb Fund, a program of the Rubin Institute for Advanced Orthopedics (RIAO) at Sinai Hospital in Baltimore, Maryland, a 501(c)(3) non-profit organization. Such funds support efforts to preserve limbs from needless amputation, provide advanced surgical treatments to patients domestically or abroad and advance patient care through research, development, and the clinical practice of the physicians and staff of the RIAO.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to Help-Save-A-Limb Incorporated and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to

any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
