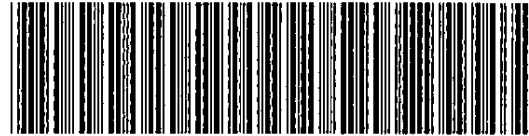

ARTICLES OF INCORPORATION OF  
SOUTH FLORIDA DUI SCHOOL, INC.  
(NON-PROFIT)

The undersigned incorporators, for the purpose of forming a not for profit corporation under Florida Statutes, Chapter 617, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be SOUTH FLORIDA SCHOOL, INC.

ARTICLE II - DURATION

The term for which the corporation shall exist shall be perpetual, and its existence shall begin on the date of the execution of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing DRIVING UNDER THE INFLUENCE (DUI) PROGRAM services, under licensure from the State of Florida, Department of Highway Safety and Motor Vehicles, Division of Driver Licenses, Bureau of Driver Education Programs.

ARTICLE IV - PRINCIPAL OFFICE AND MAILING ADDRESS
