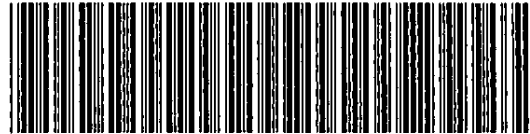

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following articles of incorporation:

ARTICLE I NAME

The name of the corporation shall be EDUCATIONAL SOCIETY FOR PEACE AND NONVIOLENCE FOUNDATION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 413 FOREST BREEZE AVE., BRANDON, FL 33511.

ARTICLE III PURPOSE (S)

The specific purpose(s) for which the Foundation is established is to provide educational assistance to students, faculty and staff that would enable them to achieve their educational goals, improve their lives and provide leadership to their communities and country.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The board of directors shall be appointed and the members shall elect its officers. The initial members of the board of directors are:

ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE VI - DISSOLUTION

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
