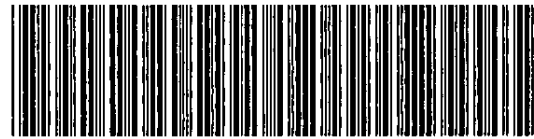

ARTICLE I NAME

The name of Corporation shall be: Human Rights in Iran Document Center, Inc.
