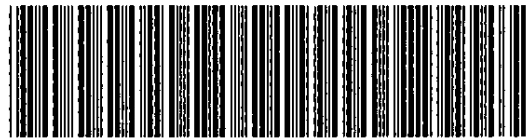

Article I

Corporate Name

The name of the corporation shall be:
Elizabeth Chapel Community Cemetery, Inc.

Article II

Principal street and mailing address is:
8008 Chumuckla Hwy, Pace, Florida 32571

Article III

Purpose

The purpose or purposes for which the Corporation is organized exclusively for maintaining the business affairs of an exempt cemetery registered under Florida statute 497.260. The Corporation is not an owner nor does it hold any legal title to real property. The Corporation will be receiving donations for perpetual care of burial plots, maintaining the grounds, assisting in burials, providing insurance, and maintaining computerized and manual records as required for a registered cemetery. The Corporation shall also manage all funds and bank accounts. This Corporation shall operate within the meaning and requirements of Section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Not part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its Members, Trustees, Officers, Directors or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and no payment and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publish or distribution of statements)

any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

Article IV

Manner of Election

The Directors/Officers will be appointed by the Board of Trustees of the Chumuckla Community Church, Inc.

The Corporation shall be operated by a Board of Directors, as set forth in Article V below, and shall appoint Director/Officers in the following capacities: President, Vice-President, Secretary/Treasurer. The initial appointed Board of Directors will elect future Directors. There will be a total of six Officers and Directors'

An Officer or Director shall not be personally liable to the Corporation or any third party for damages or breach of any duty owed to the Corporation or its members, except that nothing contained herein shall relieve an Officer or Director from liability for any breach of duty based on an act or omission: (a) in breach of such person's duty of loyalty to the Corporation; (b) not in good faith or involving a knowing violation of law; or (c) resulting in receipt by such person of an improper personal benefit. The Corporation shall indemnify and hold harmless its Directors or Officers from any cost or liability, including without limitation, reasonable attorney's fees, associated with third party claims.

New Directors/Officers shall be elected by the Board and serve three(3) year terms as further defined by the By-Laws of the Corporation.

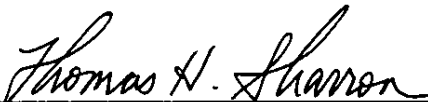
office is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

These Articles of Incorporation shall become effective as of the date of filing.

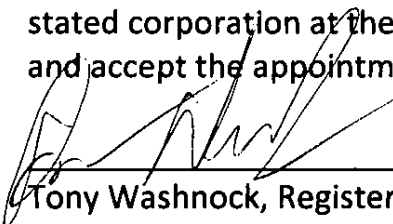
