In the event that the Foundation shall dissolve or otherwise terminate its existence, subject to the provisions of Chapters 607 and 617, Florida Statutes, the Foundation shall distribute all its existing assets to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3).
