**ARTICLES OF INCORPORATION
OF
THE CENTER FOR CONSTITUTIONAL VALUES, INC.**

ARTICLE I - NAME

The name of this corporation is: THE CENTER FOR CONSTITUTIONAL VALUES, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is: 6490 Thistle Terrace, Palm City, Florida 34990.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to:

- (1) Undertake to promote historical, educational and constitutional ideals through means including the granting of scholarships related to essay-writing on the topic of the United States Constitution;
- (2) To exercise all lawful purposes and powers set forth in the Florida Not for Profit Corporation Act which furthers the goals, objectives and purpose set forth herein;
- (3) Exclusively promote charitable, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations in a manner consistent with the provisions of Section 501(c)(3) of the Internal Revenue Code of 1954 as amended. The corporation shall have the right to exercise all of the powers granted by the laws of the State of Florida to corporations not for profit. The foregoing clauses shall not be held or construed in any way to limit or restrict the powers.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are elected and appointed shall be set forth in the Bylaws.

ARTICLE V - INITIAL OFFICERS AND/OR DIRECTORS

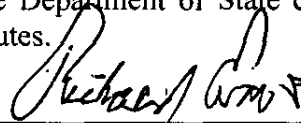
