OF

SAVE THE AFRICAN AMERICAN YOUTH, INC.

ARTICLE I

The name of the corporation is "SAVE THE AFRICAN AMERICAN YOU FINE" (the "Corporation").

ARTICLE II

The Corporation is organized pursuant to the provisions of the Florida (Not for Profit) Business Corporation Act (the "Code"), Chapter 617, Florida Statutes.

ARTICLE III

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

Notwithstanding any other provision of this document, the organization shall not carry on any activities not permitted to be carried on (a) by an organization exempt for federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section of any future federal tax code.

ARTICLE IV

The Corporation will have three classes of members.

ARTICLE V

The affairs of the Corporation shall be managed by a board of directors. The method of electing the board of directors shall be determined by the bylaws of the Corporation.

ARTICLE VI

The mailing address of the initial principal office of the Corporation is 2011 Avenue 'H' East, Riviera Beach, Florida, 33404.

ARTICLE VII

The initial registered office of the Corporation is 2011 Avenue 'H' East, Riviera Beach, Florida, 33404, in the County of Palm Beach. The initial registered agent of the Corporation is Claudius Nalls.

ARTICLE VIII

The name and address of the incorporator is: Claudius Nalls, 2011 Avenue 'H' East, Riviera Beach, Florida, 33404.

ARTICLE IX

Personal liability of all directors of the Corporation to the Corporation or its members for monetary damages for breach of duty of care or other duty as director is hereby eliminated to the extent allowed by the Florida (Not for Profit) Business Corporation Act, Chapter 617, Florida Statutes, or any successor statute.

ARTICLE X

The Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property of the Corporation and no part of its net earnings shall inure to the benefit of or be distributable to any director, member, or other benefit of or be distributable to any director, member, or other private individual. The Corporation shall never be authorized to engage in a regular business of a kind ordinarily carried on for profit or in any other activity except in furtherance of the purposes stated above for which the Corporation is organized.

No substantial part of the activities of the Corporation shall consist of attempting to influence legislation, by propaganda or otherwise. The Corporation shall not participate or intervene in (including the publishing or distribution or statements) any political campaign on behalf of or in opposition of any candidate for public office.

ARTICLE XI

In the event of the dissolution of the Corporation, to the extent allowed under applicable law, after all lawful debts and liabilities of the Corporation have been paid, all the assets of the Corporation shall be distributed to, or its assets shall be sold and the proceeds distributed to, another organization organized and operating for the same purposes for which the Corporation is organized and operating, or to one or more corporations, funds, or foundations organized and operating exclusively for religious, charitable, scientific, literary, or educational purposes, which shall be selected by the board of directors of the Corporation; provided, however, that any such recipient organization or organizations shall at the time qualify as exempt from taxation under the provisions of Section 501(a) of the Internal Revenue Code of 1986, as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding

provisions of any subsequent law. In the event that upon the dissolution of the Corporation the board of directors of the Corporation shall fail to act in the manner herein provided within the reasonable time, a court of competent jurisdiction in the county in which the principal office of the Corporation is located shall make such distribution as herein provided upon the application of one or more persons having a real interest in the Corporation or its assets.
