Article III Purpose

The purpose for which MJ Hoops is organized to provide opportunities for kids to learn to play basketball and to compete in basketball with kids from local schools and parks. In doing so, the organization also seeks to provide basketball equipment and other resources to allow kids the opportunity to play, enjoy, and compete in basketball.

Article IV Board of Directors
