OF

ARTICLES OF INCORPORATION

The undersigned President of THE MANIFEST NETWORK INC., executes these Restatement of Articles of Incorporation of THE MANIFEST NETWORK INC., pursuant to Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME
