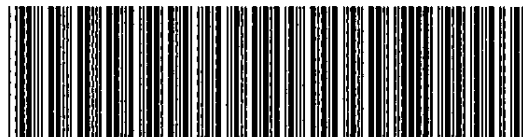

ARTICLES OF INCORPORATION
OF
DOWN N DIRTY MOTORCYCLE CLUB OF FLORIDA, INC.

A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator of a not for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I: NAME

The name of the Corporation shall be **DOWN N DIRTY MOTORCYCLE CLUB OF FLORIDA, INC.,** hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the corporation is 11145 SW 174 TERRACE MIAMI, FL 33157.

ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSES

The purpose for which the corporation is organized is exclusively for social and recreational purposes under section 501(c)(7) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose of the organization is to foster relationships among motorcycle enthusiasts and friends by providing social and recreational activities and events.

ARTICLE V: RESTRICTIONS ON ACTIVITIES

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE VI: MEMBERSHIP

The corporation shall be a non-membership organization.

ARTICLE VII: REGISTERED OFFICE AND AGENT

ARTICLE VIII: BOARD OF DIRECTORS

The Board of Directors shall consist of FOUR (4) persons. The number of directors may be increased or decreased from time to time by an amendment to the bylaws; however, there shall never be less than three directors. All directors shall be selected as provided for in the bylaws.

ARTICLE XI: DISTRIBUTION OF ASSETS UPON DISSOLUTION

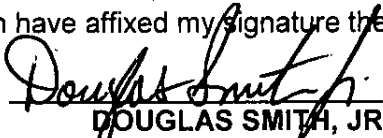

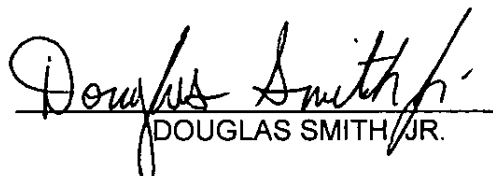
