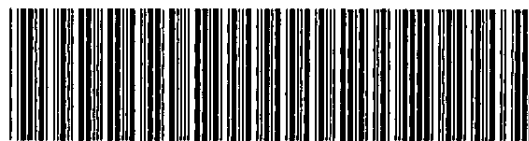

ARTICLE I NAME

KISSIMME VALLEY MISSIONARY BAPTIST ASSOCIATION, INC.

(Herein after referred to as Association)

ARTICLE II PRINCIPAL OFFICE

FIRST MISSIONARY BAPTIST CHURCH OF DEAN'S COURT

ARTICLE III PURPOSE

The general purpose of this Association shall be to create and perpetuate a union among Pastors, Ministers, and Churches. To collect funds to carry on mission and educational work of the Body. We shall further spread the gospel throughout the world and advance the kingdom of Christ in every possible way. To provide training to Pastors and members that will enlighten them to the work of the New Testament Church in a clear and contextual manner.

To provide scholarship aid to high school graduates of member churches that enroll in an institution of higher learning, vocational institutions included. Students must meet the requirements that are set forth by the Scholarship Committee and approved by the general body.

The Association shall provide support for the upkeep and operation of Florida Theological Seminary and Florida Memorial University. Members of the Association who choose to attend Florida Theological Seminary shall be reimbursed for tuition when funds are available.

The Association shall maintain membership in the Progressive Missionary and Education State Baptist Convention of Florida, Inc. and the National Baptist Convention of America, Inc.

ARTICLE IV MANNER OF ELECTION

The election of officers shall be conducted on the second day of the Annual Association Meeting. The elected officers shall be the Moderator, who shall serve as the Chairman of the Corporation; the President of the Christian Workers Congress, who shall serve as a Director for the Corporation and the President of the Ministers and Deacons Congress who shall also serve as a Director for the Corporation. A simple majority of the ballots cast is required to be elected.

The elected Moderator (Chairman) shall appoint the Vice Chairman, Secretary, and Treasurer of the Corporation.

Past Moderators will serve as a Director of the Corporation and the Board of Directors, at its first meeting shall elect a member at large as a Director.

The term of office for each Officer and Director is four (4) years and should a vacancy occur, the Chairman shall appoint a replacement with the approval of the Board of Directors.
