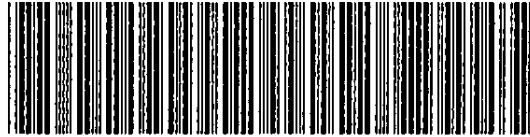

**ARTICLES OF INCORPORATION  
OF  
WEKIVA HIGH SCHOOL BAND BOOSTERS, INC.**

The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a corporation not-for-profit under the laws of the State of Florida.

ARTICLE I - Name

The name of the Corporation shall be:

WEKIVA HIGH SCHOOL BAND BOOSTERS, INC. (the "Corporation").

ARTICLE II - Principal Office and Mailing Address

The address of the principal office and the mailing address of the Corporation is 2501 N. Hiawassee Road, Apopka, Florida 32703.

ARTICLE III - Purpose

The purposes for which this Corporation is organized are:

- a. To support the directors of the band and auxiliaries of Wekiva High School, Apopka, Florida.
- b. To plan, organize, and carry-out fundraising activities for the benefit of the instrumental music program of Wekiva High School, Apopka, Florida.
- c. To assist with and promote positive and informative communication among band members, parents and legal guardians of band members, band directors, band instructors, school administration, and other interested parties of Wekiva High School, Apopka, Florida.
- d. To promote the welfare of members of the band of Wekiva High School, Apopka, Florida, by providing a safe and positive learning environment.

In general, the Corporation is organized for purposes of engaging in any activity or business permitted under the laws of the United States and of the State of Florida and shall have all of the powers enumerated in the Florida Not For Profit Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law. Specifically, the Corporation shall be organized to unite individuals and entities interested in the advancement of the Wekiva High School band program.

The Corporation shall not be operated for the primary purpose of carrying on or operating a business of a kind regularly carried on for profit.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, the Corporation's directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article.

#### ARTICLE IV - Term of Existence

The effective date upon which the Corporation shall come into existence shall be the date of filing of these Articles, and it shall exist perpetually thereafter unless dissolved according to law.

#### ARTICLE V - Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 6356 Sleepy Hollow Drive, Orlando, FL 32810 and the name of the initial registered agent of the Corporation at that address is ROBERT BASTOS.

#### ARTICLE VI - Directors

- A. The initial number of directors of the Corporation shall be six.
- B. The number of directors may be either increased or diminished from time to time by the Board of Directors in accordance with the Bylaws of the Corporation, but there shall always be at least three directors.
- C. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at any annual or special meeting thereof.
- D. Nothing in this Article shall be construed to preclude the directors from serving the Corporation in any other capacity and receiving compensation therefor.

- b. Alumni and other persons or entities interested in the progress and development of the Corporation, in accordance with the Corporation's Bylaws.

The Corporation may specify other classes of Members as set forth in the Corporation's Bylaws.

#### ARTICLE X - Bylaws

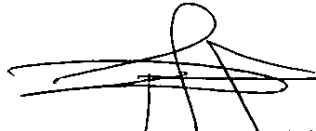
The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors.

ARTICLE XI - Dissolution

A. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all the assets of the Corporation to WEKIVA HIGH SCHOOL to be added to such school's band program; or, if WEKIVA HIGH SCHOOL ceases to exist or does not have a band program, to such organization or organizations with purposes not inconsistent with the purposes of the Corporation, with such organizations to be selected by the affirmative vote of two-thirds (2/3) of the membership of the Board of Directors.

B. Any assets not disposed of by the Board of Directors as provided herein, shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located.
