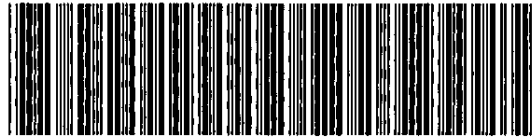

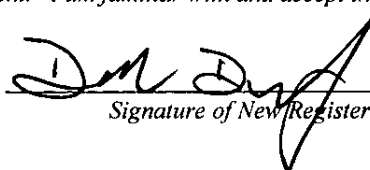

ARTICLE I

NAME, MISSION, PURPOSES, AND DISTRIBUTIONS

Section 1.01 Name

The name of the organization shall be Space Coast Veterans Alliance, Inc., hereinafter referred
to as "SCVA." It shall be a not-for-profit organization incorporated under the laws of the State of
Florida.

Section 1.02 Mission

The mission of SCVA is to provide education, advocacy, and support for veterans affected by
the complexities of military service.

Section 1.03 Purpose

The primary purposes of SCVA are:

- A. Furthering comradeship among persons who are or have been members of the Armed Forces,
- B. Conducting housing, education, health, employment and economic empowerment programs,
- C. Honoring the memory of deceased veterans and members of the Armed Forces and aiding
and comforting their survivors,
- D. Encouraging patriotism,
- E. Aiding hospitalized, disabled and needy veterans and their family dependents.
