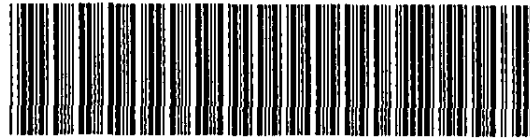

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not For Profit)

SECRETARY OF STATE

The undersigned, for the purpose of forming a non-profit corporation under the Florida Statutes Chapter 617, do hereby adopt the following Articles of Incorporation:

ARTICLE I – NAME

The name of the corporation shall be:

GRACE FELLOWSHIP CHURCH OF BONIFAY, FLORIDA, INC.

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is:

- (a) To promote the Gospel and teachings of Jesus Christ;

- (j) To engage in any lawful act or activity which may seem to the Directors capable of being conveniently or advantageously carried on or done in connection with the above stated objectives; and
- (k) To do such other things as are incidental to the purposes of this corporation or necessary or desirable in order to accomplish them.

ARTICLE IV – MANNER OF ELECTION OF DIRECTORS.

The manner in which the Directors are elected or appointed: the number of Directors on the initial Board of Directors is five (5). The directors will be elected annually in accordance with the Bylaws of this corporation but shall never be less than three Directors.
