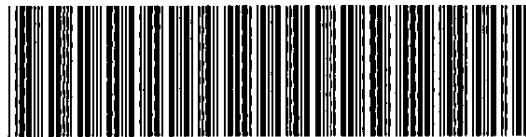

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I - NAME

The name of the corporation shall be: Gadsden County Homeless Foundation, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The purpose for which the Gadsden County Homeless Foundation, Inc. is organized is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Gadsden County Homeless Foundation, Inc. will operate exclusively as a charitable foundation within the meaning of Section 501 (c) 3 of the Internal Revenue Code of 1954 or its successor provisions exercising all powers now or hereafter available to corporations organized under the State of Florida Nonprofit corporations Act to address the issues surrounding homelessness among school aged children residing in Gadsden County, Florida that can adversely affect a student's ability to succeed school which cannot be addressed through the traditional funding sources allocated to the local school district.

ARTICLE IV - MANNER OF ELECTION

Directors shall be concerned community members appointed by the Gadsden County Parent Services Coordinator to serve a two year term.


ARTICLE VIII - DISPOSITION OF ASSETS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


ARTICLE IX - DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity




